

THE QUIET POWER OF INDICATORS

Using a power-knowledge framework, this volume critically investigates how major global indicators of national legal governance are produced, disseminated, and used, and to what effect. Original case studies include Freedom House's Freedom in the World indicator, the Global Reporting Initiative's structure for measuring and reporting on corporate social responsibility, the World Justice Project's measurement of the rule of law, the World Bank's Doing Business index, the World Bank–supported Worldwide Governance Indicators, the World Bank's Country Performance Institutional Assessment, and the Transparency International Corruption (Perceptions) index. Also examined is the use of performance indicators by the European Union for accession countries and by the U.S. Millennium Challenge Corporation in allocating U.S. aid funds.

Galit A. Sarfaty is Canada Research Chair in Global Economic Governance and an assistant professor in the Faculty of Law at the University of British Columbia.
